#### **Current situation**

- Biological residues and other waste are rarely processed in an environmentally friendly way. These by-products are seen as burdens.
- Current certification systems do not sufficiently address the specific needs of biological resources.

#### **Challenges Related to Using Waste as Raw Materials**

- Seasonality of harvests (e.g., agricultural waste).
- Potential presence of harmful compounds, such as heavy metals and pathogens.
- Climate and weather sensitivity, leading to uncertainties.
- Low social acceptance.

## **Project Objectives**

- Increase transparency in bio-based value chains by providing information on environmental performance.
- Track biological raw materials to optimize supply chain processes, comply with health and safety standards, assess environmental impacts, and promote biological raw materials in the market.
- Enhance social acceptance of bio-based products.
- Reduce greenhouse gas emissions and water pollution.
- Replace fossil resources with alternative biological resources.




#### The BioReCer ICT Tool

- A data platform, and a web application to support the project's needs and help reach its goals.
- An infrastructure based on Stellio context broker (NGSI-LD standard)
- A « mobile first » application designed for various users with different needs and expectations :
  - Certification bodies
  - **Bio-producers**
  - **Bio-industry**
- Still work in progress













#### **The BitAdvisor**




